Dear S1 Parents,

I am writing to you about the details and cost of the S1 Study Trip. This year the ELW Study Trips are similar to the trips from the previous year. We have selected A-Team Edventures who have extensive experience in Learning Trips.

A- Team Edventures:

- have a strong experience of working with both international and local HK schools,
- specialize in planning and organizing learning and adventure activities,
- are very familiar with the destinations we have chosen and our students,
- have qualified and experienced staff,
- can work with us to create a unique and memorable learning experience for all our students.

The learning focus will be a comparison between life in Cheung Chau and Hong Kong so students understand what it was once like to live in Hong Kong. The adventure activities, including rock climbing and kayaking, are challenging but safe, and will develop your child's confidence and independence. For these reasons we expect all students to take part. We ask that parents write to the Principal for NOT allowing the students to join the trip with relevant reasons. Students who do not participate in the Study Trip will need to attend school during ELW to do other learning activities. The activities will involve fees chargeable to parents.

The details of the trip will be updated regularly on the school website so you can see what your child will be doing and learning during the week.


All the above items have to reach the class teacher **on or before 24th January, 2017 (Tuesday)**. If you have any difficulties, please contact the respective class teachers.
